Fund objective

HSBC Insurance World Selection 5 Fund (the “ILP Sub-Fund”) seeks to provide long term total return by investing in a portfolio of fixed income and equity securities consistent with a high risk investment strategy.

ILP Sub-Fund investments are made by way of a feeder fund, which invests substantially all or all its assets in the HSBC Portfolios – World Selection 5 (Class ACH-SGD) (the “Underlying Sub-Fund”).

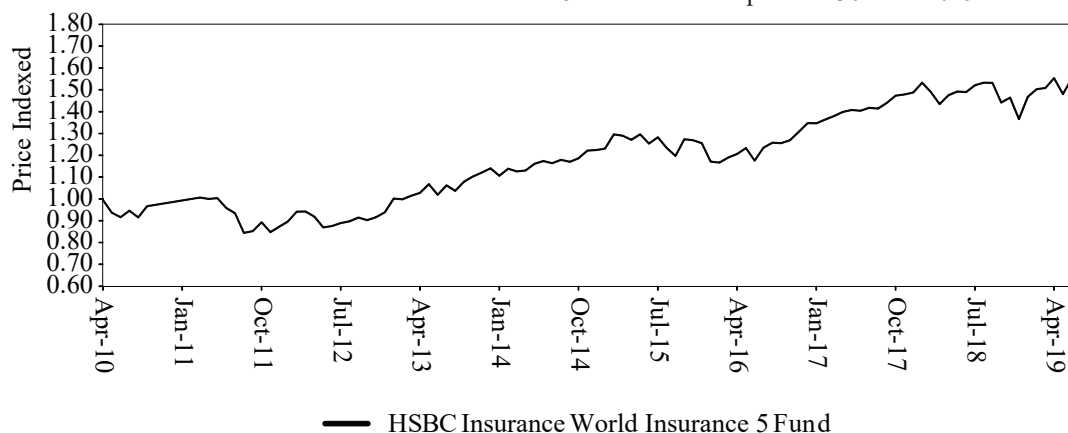
