### Fund objective

HSBC Insurance World Selection 3 Fund / HSBC Insurance World Selection 3 Fund (USD) (the “ILP Sub-Fund”) seeks to provide long term total return by investing in a portfolio of fixed income and equity securities consistent with a medium risk investment strategy.

ILP Sub-Fund investments are made by way of a feeder fund, which invests substantially all or all its assets in the HSBC Portfolios – World Selection 3 (the “Underlying Sub-Fund”).

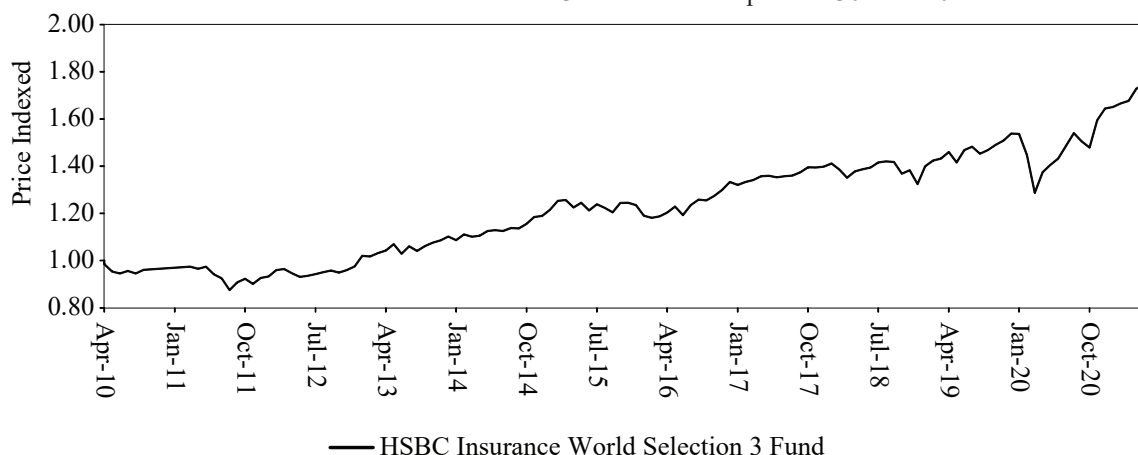

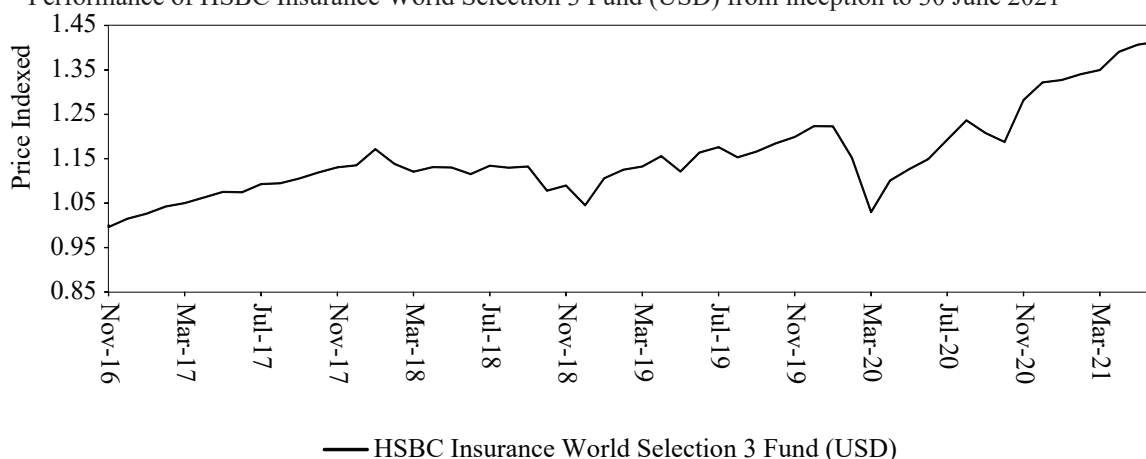
